Subject 4: "Renewal of the approval of the collective system of alternative management of used tires 'ECO-ELASTIKA SA'"

The Administrative Board of E.O.E.D.S.A.P, taking into account:

- 1) L. 2939/2001 (GG 179 A) "Packaging and alternative management of packaging and other Products Establishment of the National Organisation for Alternative Management of Packaging and Other Products (E.O.E.D.S.A.P.) and other provisions".
- 2) L. 3854/2010 (GG 94 A) "Modification of the legislation on alternative management of packaging and other products and the National Organisation for Alternative Management of Packaging and Other Products (E.O.E.D.S.A.P.) and other provisions".
- 3) PD 109/2004 (GG A 75/5.3.04) "Measures and terms on the alternative management of vehicle used tires. Program for their alternative management"
- 4) MD no. 116570/2009 (GG 408 B) "Regulation on the procedure for renewing approvals for individual or collective systems of alternative management of packaging and other products"
- 5) The request as of 30.3.2010 from the collective system of alternative management of used tires "ECO-ELASTIKA SA" (MIS p.n. 149027/31.3.2010), with which a file was submitted aimed at the renewal of the system.
- 6) The request as of 8.11.2011 made by "ECO-ELASTIKA SA" with which a modified file was submitted to E.O.E.D.S.A.P. (E.O.E.D.S.A.P. p.n. 645/8.11.2011) for the renewal of the approval of the collective system for alternative management of used tires "ECO-ELASTIKA SA".
- 7) The proposal made on 18.11.2011 by the office of E.O.E.D.S.A.P. on the renewal of the approval of the collective system for alternative management of used tires "ECO-ELASTIKA SA".

We unanimously agree

on the renewal of the approval for the collective system for alternative management of used tires "ECO-ELASTIKA SA" under the following terms and conditions:

- **1.** The system must implement its business plan, as this is described in the modified file for the renewal of the approval of the system and in any case its development to the end of the six-year approval must ensure improvement of the current percentages of utilization / recycling.
- **2.** The system is obliged to cooperate (legal cooperation bond) with licenced collectors transporters and plants (processing / utilization, storage units).
- **3.** The system is obliged to cooperate (legal cooperation bond) with licenced plants, while any denial to cooperate with a particular plant must be justified.
- **4.** Within six months following the renewal of its approval, the system is obliged to examine the potential of disposing the processed materials or energy utilization of these, in cooperation with E.O.E.D.S.A.P. and file a relevant report to E.O.E.D.S.A.P.
- **5.** Within one year from the renewal of its approval, the system is obliged to re-examine its operation cost, taking into account point 4 of the present report, and therefore the monetary contributions, and submit a new business plan to E.O.E.D.S.A.P. Among others, the said file must include a documented plan of application of the new price policy with the mechanical processing units, so as to ensure effective final processing and utilization. Also, it must include a documented evaluation on the total quantity of used tires produced in the country.
- **6.** The system must assign the inspection of the mechanical processing storage plants to independent accredited bodies, concerning the meeting of minimum standards of safety and environmental protection, including terms on fire safety. The meeting of such terms will also be a pre-requisite for cooperation with the said plants.
- **7.** Beyond the annual reports provisioned by legislation, it must submit data to E.O.E.D.S.A.P. on a six-monthly basis on the progress of its development.
- **8.** The duration of the present decision is **six years**, starting on the **23rd November 2011** and it can be renewed by modification or revision of the provisioned study, following approval of the E.O.E.D.S.A.P. Administrative Board.
- **9.** During the period of validity of the six-year approval of the system, and subject to the provisions in article 6 of PD 109/2004, E.O.E.D.S.A.P. can modify the terms of approval of the system. To this, E.O.E.D.S.A.P. requires the submission of a modified file from the system.
